

Jacobite Navigational Rally 2025

SUPPLEMENTARY REGULATIONS

1. Event

Highland Car Club Ltd ("HCC") will organise a Clubman status 12-Car Navigation Rally on the 6th December 2025, the Jacobite Navigational Rally 2025.

The event signing-on etc, will be at John M Munro Ltd, West End, Dingwall IV15 9QF (Map Reference – 5425 5925).

There will be a maximum of 49.5 miles on public & private roads. The finish venue will be at Ardross Village Hall IV17 0XW (Map Reference 21/6425 7360), which is not the location of the final control.

2. Jurisdiction

The event will be held under the National Competition Rules of Motorsport UK (incorporating the provisions of the International Sporting Code of the FIA), these Supplementary Regulations, and any written instructions that HCC may issue for the event.

3. Authorisation

The event complies with the requirements of The Motor Vehicles (Competitions and Trials) (Scotland) Regulations 1976. Motorsport UK Permit Number is 205347.

4. Eligibility

This event is open to fully elected members of HCC and members of the following invited clubs: 63CC, SDMC, Saltire Rally Club, and Caithness Car Club.

Competitors must produce a valid 2025 Club Membership Card and a Motorsport UK Competition Licence.

Drivers and Navigators require a RS Clubman licence or higher.

5. Championships

The event will be a counter in the following HCC Club Championships (eligible to HCC members only):-

- (a) HCC Training Rally Championship.
- (b) HCC Non-Expert Rally Championship
- (c) HCC Expert Rally Championship
- (d) HCC Ian C. Smith Club Championship

7. Entries

The entry fee will be refunded if the competitor advises the organisers in writing prior to the closing date for entries that their entry is withdrawn.

9. Classes

Entries for the event will be divided into the following classes:-

Expert	For which any crew may enter
Non-Expert	Any crew of which neither member has won the Non Expert (or equivalent) or higher class more than, three times whilst competing as a navigator on navigational rallies during the period from 1st October 2023 to 1st October 2025.
Novice	Any crew of which neither member has won the Novice (or equivalent) or higher class more than, three times whilst competing as a navigator on navigational rallies during the period from 1st October 2023 to 1st October 2025.
Historic	Any crew may enter. A class award will only be presented if 4 or more crews enter. This class is not eligible for points in any of the Club's championships.
Beginner	Any new crew may enter provided they have never competed in a Navigational Rally prior to this event. No class award will be presented, and this class is not eligible for points in any of the Club's championships.

The maximum entry for the event is 12 including reserves and the minimum is 5. The organisers reserve the right to amalgamate classes or cancel the event as necessary if the minimum numbers are not reached. Entries will be seeded in the following order: Expert, Non-Expert, Novice, Beginner, Historic.

10. Maps and route instructions

Ordnance Survey Landranger (1:50,000) Map Number 21 (any revision from October 2013) Dornoch & Alness, is required. Any feature of the map, legend or cardboard cover may be used to define the route to be taken. Competitors will be supplied with a timecard and route card or route instructions as necessary during the event. These documents will provide all the information necessary for competitors to comply with NCR Ch 13 App 4. The correct route will be deemed to be the shortest route which complies with the instructions, and straight-on unless otherwise instructed. All mileages are deemed to be correct.

11. Timing

Cars will start at ONE minute intervals. Timing will be Scheduled Timing by marshals watches. A clock showing rally time will be on display at signing on.

Competitors can reduce lateness without penalty in accordance with NCR Ch 13 App5 Art 5.16 & 5.19

12. Technical regulations

All vehicles must comply with the Motorsport UK technical regulations NCR Ch 7 App 2 and NCR Ch 13 App 15. Competitors should in particular note the following:-

13. General Regulations

The General Regulations of Motorsport UK apply except as modified below:-

14. Penalties

Marking and penalties will be in accordance with NCR Ch 13 App 7a except as modified below:-

Not reporting at a Passage Control or providing proof of visiting a Route Check (e.g. a Code Board) - 15 minutes.

15. Results and awards

Provisional results will be published as soon as possible after completion of the event. Any protests must be lodged in accordance with NCR Ch 2 App 9.

The following awards for this event will be presented at Highland Car Club's annual prize-giving:-

1st O/A Driver - Trophy and a perpetual award

1st O/A Navigator - Trophy and a perpetual award

1st Expert - A perpetual award to the driver and navigator

1st Non-Expert - A perpetual award to the driver and navigator

1st Novice - A perpetual award to the driver and navigator

The overall winners will be the highest placed crew in the Expert class. No competitor may win more than one award.

16. Insurance

Vehicles must have a valid motor insurance policy which provides as a minimum, Third Party Liability cover that complies with the Road Traffic Act. This can be either, by extending an existing motor policy to cover the event, or, by purchasing additional cover, providing under the Event Road Section Scheme as an adjunct to an existing motor policy. If a competitor has an extension to their existing policy, they will be required to sign a declaration that the cover complies with the requirements of the Road Traffic Act. Any responsibility for a fraudulent or misleading declaration about existing cover lies with the competitor.

The Club has applied to Kingfisher Motorsport Insurance for Event Road Section Cover, and acceptance will be confirmed in the Event Final Instructions. If a competitor wishes to purchase additional Road Section cover via the organisers then they can do so prior to the event providing they comply with:

- is aged 19 years or over
- has held a full driving licence for a minimum of 6 months
- has no more than 6 points on their licence
- has had no more than 1 fault claim in the last 3 years
- is a named driver on a valid motor insurance policy for the vehicle they are driving
- do not have the Third-Party Extension cover on their existing motor policy
- the vehicle has a valid MOT and taxed for the road, unless exempt from doing so

Anyone aged less than 19 years old will also be accepted at the same price should their co-driver be a more senior member of their family or over 25. Any competitor who falls outside these parameters may be offered cover at equivalent terms or an agreed price, if approval from the Appointed Insurance Broker has been obtained by the event organisers, prior to the event. Approval can be sought by sending an email to info@kingfishermotorsport.com and provide the Drivers' name and date of birth, the date they passed their driving test and details of any motoring claims and/or convictions.

Additional cover provided by this scheme is only effective whilst the vehicle is actively competing in the event and remains under the control or direction of the event organiser(s). Cover will cease immediately if you are precluded, excluded or retire from the event.

The Event Road Section scheme is provided by Kingfisher Motorsport Insurance underwritten by First Underwriting Ltd..

The basic rate per driver for the Insured event, before any loadings will be:
