



# Guy Fawkes Navigational Rally 2024

## Supplementary Regulations

### **(1) Announcement**

Highland Car Club Ltd (HCC) will organise a 12 Car Navigational Rally on the 3<sup>rd</sup> November 2024. *The Guy Fawkes Navigational Rally 2024.*

The event signing-on etc, will be at Ross's Garage, Clava (Map Reference – 27/754 443). There will be a maximum mileage of 49 miles on public & private roads. The finish venue will be at Ross's Garage, Clava (Map Reference – 27/754 443), which is **not** the location of the final control.

### **(2) Jurisdiction**

The event will be held under the General Regulations of Motorsport UK. (Incorporating the provisions of the International Sporting Code of the FIA), these Supplementary Regulations, and any written instructions that the organisers may issue for the event.

### **(4) Eligibility**

The event is open to members of the Organising Club and the following invited clubs.

### **(5) Licences**

Competitors must produce a valid 2024 Motorsport UK Competition Licence and Club Membership Card. Drivers and Navigators require a RS Clubman licence or higher.

The Guy Fawkes Navigational Rally 2024 will be a counter in the following Highland Car Club Championships.

## **(19) Insurance**

The entrant is required to supply the name and address of their competition insurer on the entry form. If you do not have competition insurance you may compete under the following scheme:

Vehicles must have Insurance in place which provides as a minimum, Third Party Liability cover that complies with the Road Traffic Act. This can be either, by extending an existing motor policy to cover the event, or, by purchasing additional cover as an adjunct to an existing motor policy.

If a competitor uses an extension to an existing policy, they will be required to sign a declaration that the cover complies with the requirements of the Road Traffic Act. Any responsibility for a fraudulent or misleading declaration about existing cover lies with the competitor.

If a competitor wishes purchase additional cover via the organisers, then they can do so prior to the event providing they comply with the following.

**Age 19 years or over**

**Has held a full licence for a minimum of 6 months**

**Has no more than 6 points on their licence**

**Has had no more than 1 fault claim in the last 3 years**

**The vehicle must hold a valid MOT Cert, current road insurance, and Road Tax, unless exempt from doing so.**

**All competitors MUST be a named driver on the road insurance**

Anyone aged less than 19 years old will also be accepted at the same price should their co-driver be a more senior member of their family or over 25.

Any competitor who falls outside these parameters may be offered cover at equivalent terms or an agreed price, if approval from Reis Motorsport Insurance has been obtained by the event organisers, prior to the event.

Additional cover provided by this scheme is only effective whilst the vehicle is actively competing in the event, and remains under the control or direction of the event organiser(s). Cover will cease immediately if you are precluded, excluded or retire from the event.

The Event Organiser's RTA scheme is provided by Reis Motorsport Insurance and underwritten Markerstudy Insurance Services Limited.
